As part of the Summerville DREAM "Third Thursday" events in downtown Summerville **Art Central Gallery** will sponsor an **Art Walk** on the 3rd Thursday of the month, March - October 2012. The **Art Walk** will be held on the pedestrian-only portion of Central Avenue (100 block) known as "Short Central" from 5 - 8 pm with artist booths along the street.

Show Guidelines:

- **All interested artists should submit the attached "Art Walk" application to Art Central Gallery, 130 Central Avenue, Summerville, SC 29483. Attn: Art Walk or Summerville D.R.E.A.M., 218 South Main Street Summerville, SC 29483**
- Art Walk applications will be reviewed by the Art Walk committee, and artists will be contacted shortly after by email or phone regarding their status.
- **There are no fees, but artists must have a business license for the "Town of Summerville" in order to sell. After being approved for the show, if you do not have a town license, please apply for one at Summerville Town Hall.** A business license application and information are attached for your convenience. Most artists qualify under the Class Code: "2" which is \$35/year for those in the town limits, and \$70/year for those who are outside the town limits, Licenses run June 1 – May 31 of each year. See form for details. **Business license applications and checks should be turned in to: Town of Summerville, 200 South Main Street, Summerville, SC 29483.** For more information about the licenses, visit the Town of Summerville website: <http://www.summerville.sc.us> or call Cindy Killion at Town Hall, 851-4203.
- Accepted media are: drawings, paintings, photography, sculpture, clay work, woodworking, jewelry, mosaic, basket-weaving and others considered **art or crafts**. All artwork and crafts for sale **must be hand-made by the artist** (no buy/sell), and must be appropriate for all audiences.
- Display spaces will be a maximum of 10-foot square allowing for individual set-up and display – tables, screens, etc. to be provided by the artist. Tent not required.
- Set-up will begin on each Third Thursday at 3:30 pm (or later for small set-ups) & must be completed by the start of the Art Walk at 5pm. Tear-down is 8pm.
- A signed application is a **commitment to show**.
- In case of inclement weather, artists will be contacted the day of the show for updates, so please provide accurate contact information.
- All participants agree to hold DREAM, the town of Summerville, Art Central Gallery and the employees of these organizations harmless from any liability.

Business License Information

A business license is required if you *have* a business that is located in the town limits of Summerville, or if you come into the town limits to perform any work.

The fee you will pay is based on your class code. Your business type indicates your NAICS code, which indicates which Class you are in. You can find a list of NAICS codes, rates and business license applications on our web site at www.summerville.sc.us under Business Licenses, or on your previous license.

The Business License year for the Town of Summerville is June 1st- May 31st.

The first time a business license is applied for, the gross is based on the estimated gross income you anticipate in the Town of Summerville for the remaining months in our business license year.

All business licenses renew on June 1st regardless of when it was first purchased for In-Town businesses. In most cases, Out-of-Town businesses must renew their license for each job they perform.

When licenses renew on June 1st, if you have not been in business a year, the gross is another estimate based on actual gross in the Town for the months you were in business the previous year.

The next year your gross is the actual total gross in the Town of Summerville based on the previous calendar year as reported on your tax return. Jan. – Dec.

If your business had \$0 income for the previous year, you are still required to renew at least for the base fee OR terminate your business license.

You are responsible for letting us know if you have closed your business or moved. All business licenses are automatically rolled over and will show unpaid June 1st. A 5% penalty will be added each month for any unpaid renewals *beginning July 1st*.

If you wish to close your business license with the Town of Summerville you will need to provide us with with a written request that is signed and dated in order to terminate your license.

Renewals are sent out around the middle of May. You are responsible for renewing whether or not you have received a renewal application form.

Business Licenses for the Town of Summerville, SC will expire May 31, 2011. A late penalty of five (5) percent shall be levied for each month or portion thereof after June 30, 2011.
